

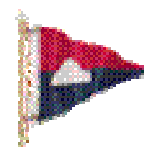

## FROM YOUR COMMODORE-Wayne Ratliff

Hello sailors,

I guess the most exciting thing happening at this time is the advent of the 2009 Summer Sailing program, commencing operations on June 15. Once again, we are blessed and favored by **Glenda Boatman** in her role as director of *Summer Sailing*. No one has her combination of experience and passion for this important club activity. Glenda is poised to tell the entire San Luis County school district that sailboat training is imminently available. Morro Bay City Parks and Recreation is advertising.

I think that Summer Sailing is one of the two primary motors that power the yacht club over the long term (The MBYC Juniors being the other). Summer Sailing and the Juniors introduce a steady stream of new sailors, members, and energy into the club. This year, we are also supported by the considerable efforts of **Michael Measures** and his Day Sailor repair team of **Don Lockwood, Bob Walker, Howard Grisham, and Larry Earl** (and maybe others). I remember very clearly last year when Glenda remarked on the embarrassment caused by the sad state of repair of the lesson boats. This year we have a lesson fleet that is above reproach.

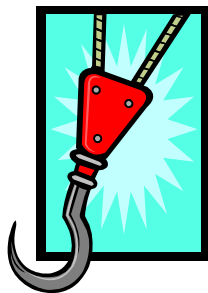
Glenda reports that we also have a super strong teaching staff. **Andrew Brown, Jonathan Dillworth, and Marin Masterson** are all certified, experienced and dedicated instructors. Jonathan just recently completed his certification, sponsored by the club.

In just a few days, we will do a preliminary modification to the hoist to double the weight capacity. This will not affect normal hoist operations in the slightest. When we have done our initial tests, we will contract a certified crane inspector to examine the hoist as it currently is and with the modification. If all goes well, we will then complete the hoist modification for use by the general membership. Basically, this involves a minor re-rigging of the hoist when lifting heavy vessels and then de-rigging. In between such special uses, the hoist will operate exactly as usual. If having this capacity might mean a change of your club use, please let me know. I currently see two member boats and the Whaler as the beneficiaries but we anticipate more.

**Maryann Stansfield** tells me that we have booked the *Morro Bay Golf Course* facilities for the 2009 Commodore's Ball. That was my first choice. My wife tells me that the 2007 Commodore's Ball, held at the golf course, was the only one that she really enjoyed (she is a tough audience) so what was I to do? You got it, the golf course.

The *Port Captain* challenges the *Board of Directors* and the membership to decide exactly what does *Policy Letter #5* mean by "use it or lose it" when it refers to "actively used boats" in our moorings. My personal criterion of "use" is when you take an ocean going boat out of the harbor entrance and into the ocean (moorings are restricted to ocean-going craft). This should be done often but perhaps not less than once a year to qualify. There apparently are members who think that using your boat as a personal/social retreat constitutes "use". I would be glad to hear all of your opinions.

Finally, *Happy Hour Hosting* has come up as an issue. I think I am honestly representing the club as a whole when I say that hosting is entirely voluntary and is likely to be so in the foreseeable future. However, (you knew that was coming) I think it unseemly to just do nothing if you are assigned a Friday host assignment. Your first recourse to an untimely service date is to try to trade dates with another host. Then you might call **Polly Schneider** to see if she and **Cynthia Wimer** can help out. In the last resort, call your co-host to tell them that they are suddenly solo or offer to have pizzas delivered, for instance. A lavish panoply of snacks and hors d'oeuvres is really nice but above and beyond the call of duty; a bag of chips and dip is perhaps the lowest bar setting.

## FROM THE PORT CAPTAIN—Kevin Williams

Ladies and gents, I believe that the time has come to define "use". "Use" will be the crux that future board action regarding moorings, and storage will hang upon. I know this term has never been adequately defined, and the spoils of this short coming lie around us. Members of the club we are up to our eyeballs in derelict boats. A good one third of all of our storage facilities are currently being used by boats that would rarely fall into any definition of "use". I would argue that the very health of our club hangs on the availability of moorings and storage space for active members and incoming members. Therefore, I strongly urge for all members to help the board in defining a workable definition of the term "use" in a way that will help to keep the fleets healthy and to aid the port captain in trimming the dead branches off this "our" family tree.

Personally, I would define "use" as activity in club sponsored events. I would be content with two club functions a year; That is two races, or two cruising events, parading, maintenance days; any mix of the above would suffice for me. Club activities that offer some form of measurable activity would go a long way in determining which boats are being used and which are "stored". There are problems with this form of measurement. There are people on the moorings that do use their boats, but not for club functions, and they should not be punished for that. I know of at least one boat that falls into this category. However, without some form of measurable of activity, i.e. club functions, where attendance can be taken, I believe "usage" would be hard to quantify. But this is only my opinion, and currently not the board's.

I do have a strong opinion on this, I base my opinion on a simple belief, that people, who rent our moorings, and occupy our storage space, should somehow directly contribute to the club. That is, if you own a racing boat then you should race, cruising boats should cruise, and so on. These moorings and storage spots are valuable assets, and should not be rented out to anyone with a craft to store but rather with something to contribute to the overall health and sailing activities of the club. There are many other moorings and storage spaces that one can store their crafts other than the club's. I urge all members to contact their representatives, and voice their opinion on this matter.

### Sharing the dock with others.

Finally, it is important that everyone has a good understanding of the *Red and Yellow* portions of the dock and the importance that they play in the health of each fleet.

The *Red section* aids greatly in the health of the *Ocean fleet*. Access to this section, at all times is of utmost concern to the fleet in regards to, pumping out, loading crew, and accessing club assets. Transients that tie in this spot should only do so for very short periods of time. Please remember that we are allowed to side tie boats up to three deep. I know at times it is hard to have transients do this, but it is important that we enforce this aspect to keep the red section open for members. We are starting into the busy period of the year, summer. Please be aware that as a big boat owner you are vying for a very desirable spot of access and that many club members are hoping to access this spot as well, weekends especially.

The *Yellow section* is of critical usage for the *Bay fleet*, I know that at times the *Ocean fleet* has balked at this but it is absolutely true. Please keep in mind that *summer sailing* is coming, classes necessitate that this space stay open during classes; Additionally, *Bay fleet* sailors need a safe and large lane to land at all times. In the past we have tried to offer this section to all ocean boats on a temporary basis, and at a great cost to the clubs inter-relationships. A dingy owner should never have to ask for what is already dedicated to them in the policy letters. Therefore, I will be strongly enforcing that this section remain open from sun up (around 9am) to sun-down (around 8 pm) do not park any boat in this section with a lead keel, it is not a dingy. I will ask the board for the proper disciplinary action for those that break this rule.

In keeping with my opening statement of the year, I am aiming for the greatest usage by the greatest number of members, usage that involves sailing, I apologize to those of you that this will effect.
