FROM YOUR COMMODORE-John Michener



Our General Membership Meeting is on Saturday April 10th at 7:00 pm. We will have the customary potluck dinner before the meeting at 6:00 pm. This is an important meeting for you to attend. We have four motions on the ballot that could have a large effect on our club. As a voting member you should have received notification by first class mail of these four motions that were made by petitions presented to the Board of Directors. All of the motions on the ballot relate to spending money from the Contingence Reserve Fund. To spend money from this fund a motion must pass by a 2/3rds majority of the members at a General Meeting providing a quorum is present to allow for a vote. A quorum means that 15 percent of the memberships in good standing are represented at the meeting.

I know that there is some confusion about the different funds that we have set up. I have to confess that I didn't have a very good understanding of them before serving on the Board of Directors and the Budget Committee. There are the Designated Reserve Funds which are set up for things that we are almost certainly going to have to spend money on in the future. Some examples are the bar, dock, deck, moorings, roof and others. We also have a fund called the Contingency Reserve Fund that is not designated for a particular future expense but is held, as you might have guessed, for contingencies or things that are not covered by the Designated Reserves. Some money is also designated to be used for general operations and is not included in any of the funds. Money that goes into these funds comes from the various sources of income that the club has such as dues, initiation fees, bar sales, ship's store, boat yard, moorings, transient fees and others. These funds are not in separate individual bank accounts but are separated in our accounting.

It was wise of the previous Boards of Directors and Budget Committees to set this up so we could save up money over time for eventual needs and then when they arise the membership would not have to be assessed to pay for them. We should be equally wise and careful in deciding how and when we should spend the money.

One of our long time members, *Phyllis Snyder*, passed away near the end of February. *Vice Commodore Barker* and I represented the Yacht Club at her memorial service. Several other members were also there. *Phyllis* was a sweet, energetic little lady. She didn't make it over to the club a lot in recent years but she will be missed.

I hope you are enjoying spring now that it is here. The nice sunny days make me want to be outside doing something fun like sailing. I'll see you out there.

Social Committee



From your Treasurer – Laura McCarren:



NOTES FROM THE FLEET CAPTAIN

Last week at dinner I had a conversation with a sailboat skipper who didn't much like racing. Over salad I tried to explain to her the ways in which racing sharpened your skills and provided a unique atmosphere in which to sharpen your skills.

"It's the intensity of it I guess," I said. "You have to pay close attention to so many things," I said. "Sail trim, tactical direction, hull efficiency—all while sailing a course." "Non racers go places too," she said, biting a crouton. "We watch our sails and go in straight lines. What's the big deal?" I hadn't thought about it so clearly before, but it occurred to me then the real reason racing's hard. "In a race you have ten other boats trying to go the exact same place. There's not room for everybody."

"Hmm," she said, giving me a funny look. Realizing I'd irritated her, I tried humor. "When I first joined the yacht club, I looked up "yacht" in the dictionary. It said it was either a pleasure craft or racing vessel. I guess I've learned that those two terms are mutually exclusive." "I see," she said. "Well racing's fun," I said. "Really." "I guess I'm not a racer." "I'm not much of one either. Pass the wine, would you?"

Having begun a new bay racing series last month, the members of our bay racing fleet spent a number of hours all trying to go the same place. While the racing results were predictable—*Kevin* and *Gail* prevailed, it was the spirit of the event that remains in my memory. In particular, I came to really appreciate *Dot* and *Pat Rygh* as not only wonderful club members, but fine teachers. I'd known this before. When *Deborah* and I were charged with PROing our first race, the *Rygh's* were by our sides on the deck—along with *Gail*, *Howard* and *Sandy*—offering encouragement and sage guidance. *Pat* and *Dot* literally took us through every phase of the race that day, from course layout, to sequencing the start, to trophy presentations with humor, good will and remarkable patience. I remember one moment in particular. After lunch on that day, the wind was faltering, and we had to decided whether to hold the last race. *Pat* pulled me aside. "There's no wind," he said, smiling under his hat. "It's hard to race with no wind." He must have been able to see my disappointment. "You're the race PRO," he said. "You and *Deb*. Take a poll and make a decision. It's yours." "You think it's foolish," I asked. "It's your call," he said. "You decide." "I can tell you think it's stupid." "I'll do what you want me to do." And hour later, after I finished retrieving boats and with a string of Daysailers behind the wailer, I radioed *Deb*. "Tell *Pat* to stop laughing," I said. "I should've listened." "He's not laughing," she said. "Well, not really. He said you did the right thing. Win some, lose some."

At last months bay race, the *Rygh's* ran the race, but just as importantly, gave a "hands-on" seminars to future PROs. Included were veterans and new members. What a joy to see them mentor and instruct; indeed, it was an object lesson in what our club is all about.

As for the racing, it was spectacular. The courses were complicated and challenging, leading to some amazing racing and amazing screw-ups, none more public than Beach Party's spectacular collapse at the finish line in the final race. Racing's fun, right *Kevin*?

General Meeting Information

The prospect of the Morro Bay Yacht Club having a lift or an elevator has been rumbling around for over three years. I'd like to take you back to where this all began, when a few people noticed a couple of the members struggling to climb up the stairs. Someone said, you know, we should have a lift for people when they get old or disabled. So it was talked about and Dana and others researched it and made a very good presentation. However, some members said they needed more information and someone else said it was no good because you couldn't even bring up a keg of beer or a box of wine. It was suggested that we have an elevator instead, that would serve a dual purpose. Later, before the November meeting, 61 members signed a petition asking the board to take another look at the possibilities of installing a LIFT (or an elevator, if that is what the majority of the membership wanted.) even though we still prefer a lift for half the price. At the November meeting we had 133 ballots, 73 ballots were in favor of the more expensive elevator, (you know who you are), and 61 original signers still wanted the less expensive lift. Now the same people who voted for the elevator do not want to pay for it.

We do not want to spend any more than is necessary, but it makes much more sense to start with monies that we already have, than try to raise it from scratch, as it could take 10 to 20 years, and by then an elevator will have doubled in price. Even if it were possible to raise \$\$\$ a year on dinners and social events it would take 15 years to reach \$\$\$\$. I don't think that is what most of the members had in mind. That being said, I do believe the board has an obligation to the membership to build something sooner rather than later. We should start to get bids without delay as it will take quite awhile to finalize plans and permits before we can break ground. In last month's Masthead, our petition asked for \$\$\$, no more, to come from the Contingency fund. We do not wish to "gut" the fund as was said in the other opinion letter. Commodore Michener appointed an elevator Chairperson and a committee was formed. We are proceeding in good faith and are very surprised and offended by the attack on the project by a small number of members who initially voted for an elevator. The project will not start until we have all the bids and know we have the funds to pay for them.

Whatever you do, please read the petition in the March Masthead and you will understand why a yes vote on the petition from the long range committee for matching funds to build an elevator would be a tragedy, as implementing that petition would be nearly impossible and impractical. By the time we could raise enough money, the account will have dwindled away to fund projects more favorable to the long- range committee.

I want to thank Jim Clinton for hours and hours of work and over 1000 pages of research and plans for a lift that would have been very practical and affordable, and give appreciation to Dana and Greg and others for their thankless efforts. Commodore Michener asked me to chair the Elevator Committee and I was happy to do so. We only want what is best for the members and what they voted for, and hope everyone, young or old, can enjoy the club as long as they live. We need all Yacht Club members who are able, to attend and vote to fund the elevator that the majority voted for in November.

Vote **YES** on \$\$\$, **NO** on matching funds.

AN OPINION BY SIXTEEN MBYC STAFF COMMODORES ON THE DANGER OF APPROVING THE PETITIONS TO TAKE THE CONTINGENCY FUNDS TO BUILD AN ELEVATOR

Well it looks like the elevator/contingency fund issue will again be on the agenda for the April General Meeting. There are two elevator petitions, that will extract all or most of the money presently in the Contingency Fund to start construction of an elevator. Petition #1 is requesting that the Club take all the funds from its Contingency Account and use these funds toward the costs for completion of the elevator and that construction to be started with as little delay as possible. That petition was published in the March Masthead. The second one will take \$\$\$ from the contingency fund to build the elevator. That petition required the Board of Directors to make a special first class mailing to the membership. You will probably have received it by now.

The Contingency Fund was built to create a war chest so that the Club would have funds for emergencies or to take advantage of opportunities that present themselves. It was used in the past to react to the deteriorating situation in the walls of the heads and showers. \$\$\$ of the Contingency Fund money was used for that repair project. The Long Range Planning Committee has been working for over a year on a project to add a ramp and a small dinghy dock to our existing water lease. If petition #1 of the elevator petitions were passed the contingency fund would be gutted and the dock project would have to be scrapped. If petition #2 of the elevator petitions were passed the dock project would have to be scrapped or the contingency fund would be totally gutted. In addition to the dock project, the Long range planning Committee has also been exploring with the City Harbor Department the possibility of putting a boat storage yard on some City property. There are three or four other projects identified by the Long Range Planning Committee that support the objectives of the YC that would have to be scrapped in order to fund either of the elevator petitions. We, Sixteen Staff Commodores, want the membership to know that we would not want the Contingency Fund gutted in order to build an elevator.
