**AN OPINION BY A NUMBER OF MBYC STAFF COMMODORES ON THE DANGER OF APPROVING THE
PETITION TO TAKE THE CONTINGENCY FUNDS TO BUILD AN ELEVATOR**

Well it looks like the elevator/contingency fund issue will again be on the agenda for the April General Meeting. This time however a group of people are requesting that the Club take all the funds from its Contingency Account and use these funds toward the costs for completion of the elevator. They also want construction to be started with as little delay as possible.

The way we see it, if this petition passes the Contingency Fund will be gutted. Not only that but should the elevator cost more than we have in the fund, this petition would force the board to move forward on construction regardless of the consequences. That being the case it would mean that any additional funds needed for construction would have to be siphoned off from the reserve accounts or trigger a membership assessment. Is this a real possibility? The Ventura Yacht Club installed an elevator recently and the final cost was in excess of \$\$\$\$. Their elevator was similar to the one proposed for us but did not need an outside structure to house it. Ours does. Since we presently have just a little over \$\$\$ in the Contingency Fund that scenario looks very probable.

The Contingency Fund was built to create a war chest so that the Club would have funds for emergencies and to take advantage of opportunities that present themselves. It was used in the past to react to the deteriorating situation in the walls of the heads and showers. \$\$\$ of the Contingency Fund money was used for that repair project. The Long Range Planning Committee has been working for over a year on a project to add a ramp and a small dinghy dock to our existing water lease. The Long range planning Committee has also been exploring with the City Harbor Department the possibility of putting a boat storage yard on some City property. These, and three or four other projects that support the objectives of the YC as called out in the by-laws, would have been or will have to be junked in order to fund this petition.

We urge a **no** vote on the elevator petition.

Letter to the Membership from the Elevator Committee

Dear MBYC Members

The Elevator Committee, consisting of *Staff Commodore Kent Butler, Staff Commodore Ted Miranda, Jim Clinton, Duncan McQueen, Marlene McQueen Chairperson, and Vice Commodore Greg Barker*, as consultant, has compiled the following information to bring to the General Meeting, April 10th, 2010 to be voted upon.

Last November the membership voted yes to install a full elevator. However, we did not vote on how much we could take out of the Contingency fund to pay for the elevator. At that time you assessed yourselves a \$\$\$ per year increase in your yearly dues, which you have already paid for in this years dues.

At the April Meeting, you will be asked to vote to use \$\$\$ from the contingency fund for an elevator. If we don't use the entire amount, the excess will remain in the contingency fund and if more is needed we will have a variety of fundraisers to make up the difference. We already have some donations and are looking forward to more.

As an alternative to putting the elevator at the South (back) entrance, we are looking at the possibility of constructing one near the front entrance. If this is feasible, we can probably save some money, as we will not have to move the stairway and laundry facility. In any case, there will be ample funds left for a new dinghy dock as requested by the long-range committee. Once we know we have funds available, we will obtain bids from several contractors and proceed from there. Enclosed, in your Masthead, you will find the petition initiated by *Anne Miranda* and signed by 9 members in good standing.

So please mark your calendars for April 10th. We will need a quorum and 2/3-yes vote from those in attendance to earmark this money. If anyone needs a ride, please call *Marlene* or *Duncan* and we will see that you get to the meeting and back. There will also be a pot-luck dinner that evening starting at 6:pm, meeting at 7:00pm.
