## FROM YOUR VICE COMMODORE



### Ahoy Mates

I am happy that summer is over and the sun is out. It was June gloom that lasted into fall and I am happy to see the sun.

It has been a busy month for the Vice Commodore as a number of projects have been completed and some new ones started. Early in the month we had an electrical malfunction on the dock and John

Bodine responded by replacing a defective breaker. The dock electrical system is now working but it is in need of major repair. Two 30 amp breakers are totally out of commission and the entire system is unsafe. Thomas Electric Co. engineers have designed a new system and prepared a plan for replacing the existing system. Their proposal will go to the board next month. If you have questions give me a call.

Bear Pest Control came by and treated several area of the clubhouse for dry wall termites. They treated all areas they could find but forewarned us of the possibility of needing to tent the building next year.

After being checked in April, the back flow regulator sprung a leak and was judged to be defective. It has to be tested each year and barely passed inspection the last few years. So, I decided to have it replaced. It should, for many years, keep the kind of water we don't want to drink from getting into the water we do drink. At least, that is the hope and the plan.

The bench supports for the benches in the shower dressing areas finally arrived from the welder. Dana McClish

brought his hammer drill and together we managed to install the bench supports. If you choose to use them now do so at your own risk. A stainless steel splinter in your "you know what" would be a problem the VC is unwilling to fix. The supports now await the solid surface guy who will supply the bench seat material. Clothes hooks are next.

We are making an attempt to clean up the storage areas and have noticed a number of personal items being stored in club storage areas. We are asking that all personal items other than boats and trailers be removed. If it won't fit **in** your boat or **on** your boat, please take it home.

An additional paper towel dispenser has been placed in each head. Help with the installation was spontaneous and came from both Rachelle and Bob Kizziar with Jenny serving as supervisor. 
The Harbor Festival is scheduled for the first weekend in October, the cruising fleet plans to anchor out in the federal anchorage. Come and join us.
